
- 1] संस्था अनुदान की मांग नहीं करेगी ।
- 2] संस्था में प्रशिक्षित अध्यापकों को ही नियुक्त किया जाएगा ।
- 3] राजस्थान गैर सरकारी शैक्षिक संस्था अधिनियम, 1989 एवं नियम, 1993 के प्रावधानों की यथोचित पालना की जाएगी ।
- 4] माध्यमिक शिक्षा बोर्ड के विनियमनों व निर्देशों की पालना करनी होगी ।
- 5] मान्यता हेतु एवं नये विषय प्रारंभ करने हेतु संस्था द्वारा निर्धारित फिज तकस कार्यालय में जमा करानी होगी ।
- 6] पहले वर्ष में कक्षा 11 एवं उसके बाद कक्षा 12 प्रारंभ की जाएगी ।
- 7] अतिरिक्त विषय एवं संकाय के लिए संस्था को पर्याप्त भवन एवं प्रयोगशाला आदि की व्यवस्था करनी होगी । यदि माध्यमिक शिक्षा बोर्ड द्वारा निरीक्षण के समय उत्तम कोताही बरती गई तो संस्था की मान्यता निरस्त करने की कार्यवाही करते हुए विद्यमान नियमों में अन्य आवश्यक कार्यवाही करने पर विचार किया जाएगा ।
- 8] इन शर्तों हेतु निर्धारित आरक्षित कोष रक्का होगा एवं भवन सुरक्षा के संबंध में प्रतिवर्ष तकस अधिकारी के आवश्यक प्रमाण पत्र लेना होगा ।
- 9] विद्यालय के पते/स्थान में बिना किसी विभागीय स्वीकृति के परिवर्तन नहीं किया जाएगा ।






